How we collect and use (process) your personal information

evolv Consulting collects personal information about its website visitors and customers. With a few exceptions, this information is generally limited to:

- name
- job title
- employer name
- work address
- work email
- work phone number

We use this information to provide prospects and customers with services. We do not sell personal information to anyone and only share it with third parties who are facilitating the delivery of our services.

From time to time, evolv Consulting receives personal information about individuals from third parties. Typically, information collected from third parties will include further details on your employer or industry. We may also collect your personal data from a third-party website (e.g. LinkedIn).

Use of the evolv Consulting Website

Cookies and tracking technologies

Sharing information with third parties

The personal information evolv Consulting collects from you is stored in one or more databases hosted by third parties located in the United States. These third parties do not use or have access to your personal information for any purpose other than cloud storage and retrieval. On occasion, evolv Consulting engages third parties to send information to you, including information about our products, services, and events.

evolv Consulting uses a limited number of trusted third-party subprocessors to support internal operations and service delivery. A complete list is available upon request.

We do not otherwise reveal your personal data to non-evolv Consulting persons or businesses for their independent use unless: (1) you request or authorize it; (2) it's in connection with evolv Consulting-hosted and co-sponsored events; (3) the information is provided to comply with the law; (4) the information is provided to our agents, vendors or service providers who perform functions on our behalf; (5) to address emergencies or acts of God; or (6) to address disputes or claims. We may also gather aggregated data about our services and website visitors and disclose the results of such aggregated (but not personally identifiable) information to our partners, service providers, advertisers, and/or other third parties for marketing or promotional purposes.

Transferring personal data to the U.S.

evolv Consulting has its headquarters in the United States. Information we collect about you will be processed in the United States. By using evolv Consulting's services, you acknowledge that your personal information will be processed in the United States. The United States has not received a finding of "adequacy" from the European Union under Article 45 of the GDPR. Pursuant to Article 46, evolv Consulting provides appropriate safeguards through standard data protection clauses.

Depending on the circumstance, evolv Consulting may collect and transfer personal data with consent, to perform a contract, or for compelling legitimate interests. evolv Consulting applies safeguards to protect privacy and enters into data processing agreements where feasible. Since its founding, evolv Consulting has received zero government requests for information.
